not what it used to be with "super grades." Director Ross said that people who have spoken to him applaud the cum laude system but feel that YSD-1 could do both. Vice President Roth said that for the last couple of years there has been a question of who the #1 student is because the students are neck in neck with their GPAs.

8.6 Culturally and Linguistically Diverse (CLD) Pay Scale Proposal

With this proposal we are preparing our educators and getting our pay scale system updated. The CDE really likes the things YSD-1 is doing regarding our ELL and Bilingual Aides, but one area we are lagging behind is CLD certification which is made for staff with a population like Yuma's. YSD-1 desires to put incentives where we want them to be and drive healthy change. We want to show that we are serious about helping our ELL students and we are serious about rewarding our staff. This certification of CLD is currently for life with no follow ups, but that could change as the state looks more into CLD. Staff would be able to use this certification wherever they go.

8.7 Milk Bid for 2013-2014 School Year

Mr. Sabo, Food Service Director, stated that Sterling Milk, whose bid we had accepted last month, was unable to continue delivering to YSD-1 due to financial reasons. We have a request for rebid into Cash-Wa and are also talking to the Western Dairy Association to see if they could help us as well. Right now, we are temporarily using Thompson Company to get our milk supply, but their prices are not fixed and they do not like delivering to more than one location. Thompson Company is who we get the majority of our food order from.

8.8 Information Update for Bank of Colorado

We have the official paper for the Board to sign to add Ana Arvizo as the LIP Director and to clean up our internet banking account viewers. We have a lot of old administrators who are still able to view our accounts and we just need to clean that up to reflect current administration. Business Manager Dennis-Murphy plans to make this a yearly change to keep that information current.

Highlights of the Last 4 Weeks

- Fiber is complete except for one panel, which is expected to be installed on Monday, the 16th.
- Prometheus Boards are installed and training on them will begin next month.
- Buildings and Grounds work
 - o We are trying to find a contractor who will work with us long term on the HVAC system.
 - o We are looking into room by room solutions for the hot part of the school buildings.
- Sport season has started. The football field is looking exceptional.
- We have 4 new board members by acclamation and don't have to have an election.
- One member will be appointed by the new board and we will get a policy packet to the new board members thank you Mr. Ross for mentioning that.
- TCAP scores were released they were late this year

TCAP Results

- Minor but measurable improvement
- Good differentiation between low, mid, and high level groups
- Most improvement still being implemented we are looking at redoing our reading curriculum in the elementary. We are not done by a long shot with improvements to curriculum.
- CO State Accreditation underway we are pre-slated to be re-accreditated in June.

October Count Estimate

- Up about 4 students from last year instead of projected down 4.
- After the October count and bond issue in November, we will re-budget.

Salary Pay Scale Proposal

- We had our initial meeting with our bilingual aides
- Assessments are underway they will be tested in proficiency in both English and Spanish
- We are still gathering feedback on restructuring our pay scale and we will re-budget after the election.
- We want to have a more normal/predictable pattern of pay and will be releasing official spreadsheets later this month.
