11.0 SUPERINTENDENT'S REPORT

The Common Core - Crisis in Yuma

Mr. Stannard has been getting numerous calls regarding a widely distributed business publication titled; "Common Core Teaches Children Obama is the Messiah". It is an article referring to a book by Nikki Grimes called *Barack Obama: Son of Promise, Child of Hope* that has made its way into the Common Core 3rd grade curriculum in various districts across the country. Mr. Stannard feels the Common Core is putting less emphasis on fiction in classical literature and more emphasis on nonfiction works such as the book mentioned above – an opinion observed nationwide. In light of this crisis- Mr. Stannard addressed the Board to specifically provide information surrounding the Common Core and Yuma School District's current position.

What is the Common Core?

- The Common Core standards are a national set of expectations for what students are supposed to know
 in math and language arts in order to graduate prepared for college and work. The standards apply only
 to math and English, emphasizing evidence-based argument and deeper understanding of fewer topics in
 math.
- Prodded by federal incentives, 45 states and the District of Columbia have adopted these more rigorous standards since they were published in 2010. Proponents say that the standards raise the bar for students and allow for common expectations and testing across states.
- Along with the standards comes a new set of tests, developed by a coalition of states known as the Partnership for Assessment of Readiness for College and Careers (PARCC). These tests are being piloted this year. Instead of seeing the TCAP testing, we will begin to see PARCC.

According to Chalkbeat.org,

"If schools adopt the standards as they are intended, then parents should expect to see big changes in what their children are taught and how they're tested. Students will be taking more and harder online tests each year. Test scores are likely to drop the first year under the new standards, as they have in other states (like New York) that have adopted the Common Core state standards, exposing wide gaps between the work students can currently do and what the standards imagine."
