Scott had copies for the audit report for every board member. Scott began by explaining the material; the first letter was explaining their responsibilities and the schools responsibilities, as well as the journal entries that they do while doing the audit. The second letter is a summary of the report. Scott then went on to discuss the audit report. The first 3 pages explains their opinion of the audit, the District is fairly presented in accordance with what is accepted. A page 4-11 is the Management's Discussion and Analysis, this is an analytical overview of the district it is a lead into the audit, Scott encourages the board to read through that summary. Then on page 48 is the General Fund as well as the Preschool fund. Scott explains that the school is at a very health reserve, it is a good place to be at the end of the year. On page 60 is the Capital Reserve Fund, Scott explains that money is moved in to the account as needed in our District. Then Scott explains the Bond Redemption Fund, this is the tax that is collected to pay the principal and interest to pay for our capital projects. Then discussed the Food Service Fund, this accounts for all the cost in providing the food service. Shows what families pay and what the District is spending. The last fund is the Pupil Activity fund and this accounts for all the clubs and organizations. They did exceed the appropriate budget, but it isn't a big deal. After explaining all the different funds Scott explains the graphs in the white packet these are just a comparison of 2011-2014.
