8.0 DISCUSSION ITEMS

8.1 Mill Levy Certification

 Business Manager Dennis-Murphy gave an explanation of this year's Mill Levy and the Bond Redemption. The General Fund Mill is set at 28.733 for this year with the Bond Redemption Fund Mill set at 8.482, total Mill Levy for this year is 37.215.

Motion by Brown, seconded by Roundtree, to approve the Mill Levy Certification as presented. Voting Aye: Brown, Cooper, Deering, Galles, Roundtree. Motion carried.

8.2 Auditorium Discussion and Approval

 Superintendent Chrisman reviewed 2 proposals for Phase 2 of the auditorium renovation to replace the seating. The 1st proposal is from BROC for \$150,360 and the 2nd proposal is from H2I Group for \$124,490. Both layouts expand the space between seats and accommodate handicap seating. Motion by Cooper, seconded by Galles, to approve the proposal from H2I Group with renovation costs totaling \$124,490 as presented.

8.3 Adult Meal Prices

- Superintendent Chrisman shared that we had been notified by the USDA that we
 were under charging for breakfast and lunch meal prices for adults which is a non
 compliance issue.
- After visiting with our contact at CDE with nutrition for USDA, it is recommended to increase prices for breakfast to \$2.30 and lunch to \$5.00. Lunch will raise a little more to offset what we had been undercharging to avoid transferring funds to cover the difference.
- Processes have been put in place to prevent this from happening in the future.

Motion by Cooper, seconded by Brown, to approve the increase of adult meal prices to \$2.30 for breakfast and \$5.00 for lunch.

9.0 SUPERINTENDENT REPORT

- Superintendent Chrisman invited former Board President Duane Brown to share about an awards banquet that he had attended where Neenan received an award on the design they had done for the Yuma High School renovations.

- BOCES retreat will be held January 29th at Red Willow in Yuma.
- Discussed with the Board if they want to proceed with having a Board retreat in January as we have done in the past.
