- Superintendent Chrisman and Human Resources Director Janna Young met with the insurance committee and they are recommending switching over to CEBT. Hoping this will be a long term option and it will be more cost effective for the district and the employees that carry our insurance.
- Will still have Delta Dental and VSP for dental and vision insurance.
